

FOUNTAIN CITY RECYCLING – recycling bins or carts are provided and owned by Hilltopper Recycling. Pickup days are the circled dates on the calendar. Please put out curbside by 7:00 a.m. to ensure you are not missed. Recycling bins indicate to contracted hauler that they should stop to pick up recycled materials. **

RECYCLING CENTER – will be open on the boxed dates from 8-11 a.m. (See Tipping Fees on back.)

PREPARE AND SEPARATE RECYCLABLES

RIGIDS -

RIGIDS PLACE IN RECYCLING BIN/CART (EXCESS RIGID RECYCLING IN PAPER BAG OR CONTAINER)

**** THEY DO NOT HAVE TO BE SEPARATED ****

PLASTIC – Rinse thoroughly. Caps DO NOT have to be removed. No. 1 or 2 will be accepted.

GLASS – Avoid breaking. Caps DO NOT have to be removed. No need to separate colored glass. No cups.

TIN & METAL – Rinse thoroughly – DO NOT have to remove labels.

ALUMINUM & AEROSOL CANS

FIBERS -

PLACE IN SEPARATE CONTAINER OR PAPER BAG NEXT TO RECYCLING BIN/CART (INTERMIXED)

NEWSPAPER – Tie in bundles or place in container or paper bag.

MAGAZINES – Tie in bundles or place in container or paper bag.

BROWN CARDBOARD – Flatten and tie or place in container or paper bag.

PHONEBOOKS & CATALOGS – Place in container or paper bag.

If there is a problem with the recyclables not prepared or separated as above, Hilltopper Recycling, may leave a sticker explaining what was not done properly.
